In addition to the credit application, we may also require the following:

1. Income source check stub or remittance portion of check
2. Bank statement, if income source is from savings, cash deposit certificate, etc.
3. Student aid or grant letter or notification, if income source is same
4. If self-employed, previous year's tax return, 1099, K-1, or any other document that can verify source of income
